What is my water rate?

NextEra Water Texas rates are approved by the Public Utilities Commission of Texas ("PUC") through our tariffs and comply with the PUC Chapter 24 Rules. The most recent rates are posted as soon as official documents are available to us from the PUC. NextEra Water Texas rates cover the cost of water treatment, water storage, transporting water to its customers (known as base rates) as well as usage, which is charged on a per thousand gallons basis.

An additional pass-through gallonage charge per 1,000 gallons of water will be added for fees imposed by any non-affiliated third-party water supplier or underground water district having jurisdiction over the utility, including: Bluebonnet GRP (BGCD), Brazoria GRP (BCGCD), City of Rosenburg GRP (CR), Harris Galveston Subsidence District (HGSD), North Fort Bend GRP (NFBWA), West Harris County Regional Water Authority (WHCRWA), North Harris County Regional Water Authority (NHCRWA), San Jacinto River Authority GRP (SJRA) and Shaw Acres.

Each pass-through gallonage charge is represented in the table below and is applicable only to the subdivisions and public water systems listed in the table on tariff page 2. SEE PURCHASED WATER AND/OR DISTRICT FEE PASS THROUGH CLAUSE.
